Eligible Dealers

All Yard Card Canada PLUS Commercial Dealers established with TDFS Inc., are eligible for the base programs listed below. These programs can be used at any time to close sales.

Eligible Products

In most cases, the dealer's full line of products are eligible for financing, including new and used equipment and parts, service warranties and landscaping supplies. (Only guns, ammunition, jewelry, licensed or registered vehicles, and boats are excluded).

Plan Number

A plan number is required on every sales transaction. Plan number drives the customer's terms. Refer to specific programs and promotions for plan numbers. Authorization code and date must be included.

Plan Description
